6. New Business

Andrew Ortwein, on behalf of Ortwein International, has submitted a façade grant request in the amount of \$4,252.50 for the restoration of the external wall that was damaged by the fire that destroyed the former Vinnie's Restaurant. Once the remaining brick is demolished, siding that matches the face of the building is proposed to be installed. Unfortunately, once the remaining brick is removed, the northwest corner of Andrew's building will be totally exposed. The entire situation surrounding the fire has been both unique and challenging. The property owner of the Vinnie's parcel chose not to rebuild and deployed insurance funds elsewhere. The parcel was sold to an individual that was experiencing severe financial and legal problems. The City worked through the court system to receive authority to bring the site back to a safe condition.

Mr. Ortwein has respectfully requested that the \$100 application fee be waived due to the extraordinary circumstances that have been out of his control.


